Janice Engle was welcomed to the club as our newest member, and membership renewal forms for 2014 were distributed to all of those at the Banquet.

Events to be held in 2014 were discussed:

We have Birt Arena reserved for our traditional Spring Clinic on April 13, 2014. The format for this event may be changed to open it to large equine in order to increase participation and make it financially successful. Outdoor areas at Birt Arena could also be utilized, weather permitting. This will be discussed further via phone/email and finalized at our next meeting.

As discussed previously, we relinquished our arena reservation in June and will substitute a picnic/playday at Eagle Island State Park which will be pot luck. We can plan a variety of cart or in-hand horse activities. This will be an informal gathering without a park reservation. Date and time will be announced later.

Because of our meager profit this year from doing the Sept. ISHSA show, we had not committed to doing it again in 2014. In checking the Birt Arena schedule, no other viable dates were available. Gwynne contacted the show secretary from the four judge QH/Paint show in Pocatello to which we lost some of our exhibitors. There will be another show there in 2014, but it will be only QH and not combined with Paint. Gwynne had also heard from an ID QH Youth Advisor, asking about our show - so that group may decide to stay local rather than going to Pocatello. Anne Gahley said that several Paint/mule people would support our show if we have it again, and the exhibitors who attended our show urged us to keep doing it. Various other clubs and the ISHSA people indicated that attendance at all shows had been down this past year. In light of that information, Gwynne made a motion that we try it again on Sept. 20, 2014. It was seconded by Susie Marler and passed. Lois urged everyone to support this show by participating in classes and working in various positions to make it a success.

After ISHSA has its annual meeting in January (Lois Cant is our liaison) our club will have another general meeting in February to work out further details on this September show and our other events. Membership will be notified of date, time and place.

Susie Marler made the motion to adjourn at 3:15pm and it seconded by Cheyenne Hackney.

## **Proposed Bylaws Amendment**

Gwynne Shaw (Secretary/Treasurer) is proposing a Bylaws amendment to be voted on at our April 13<sup>th</sup> meeting.

Reason: For the last several years, there has been no contention for Executive Board positions and no write-in candidates on ballots received. Mailing of ballots costs the club \$25 or more, and we have had only about 50% of ballots returned (in spite of providing postage-paid return envelopes.) We are a small club that often struggles to fill all the Board positions required by our Bylaws. This amendment reflects the election procedure that we've been following in practice for several years and eliminates the cost and bother of mailing ballots when they are not needed.

Refer to current Bylaws Section 305. 2. Voting, and Section 804. 1. Nominating Committee. Bylaws can be found on our website www.idahominiaturehorseclub.com if you do not keep a hard copy.

Currently, if the only position to be filled is a Director, and that person is unopposed in the slate of officers presented in October, the President shall accept that slate and declare that the nominee is duly elected prior to the conclusion of the November meeting.

It is proposed that, if the slate of officers presented at the October General Membership meeting consists wholly of Board Members who are unopposed, and there are no other candidates declared to the Secretary by November 4<sup>th</sup>, the slate of officers presented in October shall stand as duly elected, and the provision for mailing of written ballots in Section 305.2. shall be waived.

This will allow two weeks after our October meeting (held during the Hallowed Hauntings Playday mid-October) for any member to declare opposition to a Board member proposed on the slate of officers presented at that meeting. In that case, written ballots must be mailed to all qualified members.

# In Cold Weather, Horses Will Reduce Water Consumption and Be at Risk of Colic

Excerpt from PennState College of Agricultural Services, posted 11-26-12

During the winter months horses should not be fed excessively cold water, as it may bring on colic symptoms. Try a heated waterer or consider taking warm buckets out when it's cold outside. If nothing else, make sure to break the ice on a horse's water supply in freezing temperatures.

Water makes up most of the blood that carries nutrients to cells and takes waste products away. Horses that are not drinking enough water will reduce their feed intake and reduce the energy intake.

During the bitter cold weather is when horses need to keep up their energy sources and the worst possible thing that can happen is to have a horse quit drinking water and go off feed. If the horse cannot get to water because it is frozen solid, the horse becomes dehydrated.

Within 24 hours of water deprivation, a horse can lose about 4% of his body weight. After 48 hours without water, 6.8% of his body weight will be lost, and after 72 hours it's about 9%.

Symptoms of dehydration -- dry mucous membranes, sunken eyes, a tucked-up appearance, skin that has lost its elasticity, and a slowed capillary refill time -- only become obvious when the horse has already lost 6% of his body weight or more, by which time dehydration has already begun affecting digestive efficiency. When this happens the body cannot maintain a constant body temperature and becomes hypothermic.

The worst risk caused by lack of water is that the horse's intestines become impacted and results in colic. In fact, the main reason the incidence of colic increases from December to March is that many horses don't drink enough water in the winter months.
