Minutes of IDAMHC General Meeting April 12, 2014

Meeting was called to order at 1:00pm by President Lois Cant during lunch break at our Spring Training Clinic at Birt Arena in Nampa.

In attendance were Lois Cant, Gwynne Shaw, Maria Redinger, Susan Welch, Kat Hunt, new member Kim MacKinnon, and guest Rose Williams.

Rose had just completed a presentation about the driving dressage trial to be given at A Drive In the Park, sponsored by Treasure Valley Whips, at Idaho Center June 6-7, 2014. A similar trial will be done at Birt Arena on April 26, 2014 for those who may wish to observe.

Lois welcomed new members, Kat Hunt (who joined at our meeting in March) and Kim MacKinnon (who joined at this event.) We are all excited to have these nice ladies as part of our club.

Maria made the motion to accept Minutes of the March 2nd meeting, as published on the website and in our last Newsletter. That was seconded by Kat and passed.

Old Business

We will likely use the picnic area adjacent to the Trail Head Parking Lot, and set up under the "first come" rule in the Park. Remember, you can get an annual Parks Pass for only \$10 when you renew your Idaho license plate.

The trail driving gang is planning more weekday trips out to Eagle Island, so contact Susan Welch if you are interesting in getting in on the fun. They may also set up a cones course for those who want to practice that for participation in some of the Treasure Valley Whips activities.

A 2nd judge has been secured for our club's ISHSA open show Sept. 20 and the show bill has been submitted for approval. Once that has been done, it will be posted on our website. It was decided to do another Silent Auction at this event to raise funds for the club. If you have any items from your spring cleaning spree that could help us, please set them aside or pass them on to one of the Board members. It was also suggested that, if we were able to acquire a "big ticket" item, we could sell raffle tickets at events throughout the show season and have a drawing in the Fall. We just need to have something appropriate donated, and are open to suggestions.

New Business

The Idaho Buckskin club is doing an ISHSA open show at Birt Arena May 3. Rose reminded us that the driving show will be at the Fair in Boise the 3rd weekend in August. Entries are generally due by Aug. 1st and ore details will follow.

West Nile Virus Shots

Since 1999 when the WNV established itself in the eastern U.S., it has spread across the entire country. This mosquito-transmitted disease occurs when a mosquito bites an infected bird, then bites another bird, mammal or human. It doesn't help that birds can travel over long distances in a short amount of time.

Once bitten, your horse may take only 5-15 days for symptoms to show up:

- Muzzle Tremors: the muzzle will twitch for hours and sometimes for days.
- Muscle Twitching: the horse looks like he is trying to get flies off his body.
- Depression is common. Anxieties and sweating may occur.
- · Head pressing, aimless wandering or circling,
- Facial Paralysis on one or both sides of face.
- Vertigo-Balance problems: leaning on a wall to stand up, or stumbling.
- Tongue Paralysis: the horse doesn't seem to be able to pull its own tongue back in.
- Weak. Stiff walking. Tired.
- Impaired vision
- Convulsions
- Collapse: in advanced cases either front or rear or all four legs.

In cases of WNV, 33% will die, 50% will fully recover and 17% will have problem recoveries - relapse or incomplete recovery. Once a horse has contracted the disease, there is no specific medicine but your vet can provide therapy that

may save its life: treating any fever, IV for fluids or feeding, slinging to keep it on it's feet, and head/leg protection. Recovery may start in as little as 3-5 days, but full recovery can take as long as 6 months.

Vaccines initially require 2 doses and the horse is not fully protected for 4-6 weeks after the 2nd dose. Boosters are recommended at least annually. The vaccines are not very expensive when you consider the risk.

In addition, protect your horses the same as your other "family" by taking measures to eliminate any standing water where mosquitoes can breed, keep horses inside at dusk/dawn when mosquitoes are most prevalent, use repellents, screens, flysheets, bug zappers...

Let's keep our little equine friends safe!

Dwarfism in Miniature Horses

Established in 1986, the Animal Genetic Testing & Research Laboratory in Lexington KY offers genetic testing services to horse owners and breed registries, including identification of genetic markers for inheritable problems. Dwarfism is a genetic disorder that is most common in American Miniature Horses (it also occurs much more rarely in European miniature horses and Friesians). Some estimates suggest that over 50% of American Miniature Horses are carriers.

Four gene mutations associated with dwarfism have been found in Miniature Horses. At least one of these mutations is lethal in combination with any of the others, causing early pregnancy loss. The presence of two mutations in any combination will lead to early abortion, or in live foals with a wide range of physical ailments associated with dwarfism. These include breathing problems, malformed mouths, premature arthritis, and abnormal growth resulting in the horse being unsound. The severity of the disorder can range from mild (horse functions normally but has poor conformation in comparison with the breed standard) to severely malformed with a short lifespan. Since dwarfism is recessive, the appearance of a dwarf foal means BOTH parents are carriers.

Horses carrying only one of the mutations are normal in appearance, exhibiting the desired stature and proportions of the Miniature Horse.

DNA testing is done using hair samples, and a full panel test is \$150. Submission forms and sample collection instructions are available on their website at http://www2.ca.uky.edu/gluck/agtrl.asp

Proposed Bylaws Amendment

(re-print from previous Newsletter)

Gwynne Shaw (Secretary/Treasurer) is proposing a Bylaws amendment to be voted on at our April 13th meeting.

Reason: For the last several years, there has been no contention for Executive Board positions and no write-in candidates on ballots received. Mailing of ballots costs the club \$25 or more, and we have had only about 50% of ballots returned (in spite of providing postage-paid return envelopes.) We are a small club that often struggles to fill all the Board positions required by our Bylaws. This amendment reflects the election procedure that we've been following in practice for several years and eliminates the cost and bother of mailing ballots when they are not needed.

Refer to current Bylaws Section 305. 2. Voting, and Section 804. 1. Nominating Committee. Bylaws can be found on our website www.idahominiaturehorseclub.com if you do not keep a hard copy.

Currently, if the only position to be filled is a Director, and that person is unopposed in the slate of officers presented in October, the President shall accept that slate and declare that the nominee is duly elected prior to the conclusion of the November meeting.

It is proposed that, if the slate of officers presented at the October General Membership meeting consists wholly of Board Members who are unopposed, and there are no other candidates declared to the Secretary by November 4th, the slate of officers presented in October shall stand as duly elected, and the provision for mailing of written ballots in Section 305.2. shall be waived.

This will allow two weeks after our October meeting (held during the Hallowed Hauntings Playday mid-October) for any member to declare opposition to a Board member proposed on the slate of officers presented at that meeting. In that case, written ballots must be mailed to all qualified members.


Vote was delayed because of poor attendance at April meeting and will be brought for a vote at the next general meeting.
