THE THERAPY HORSE

Therapy horses bring so much joy and comfort to adults and children alike and there is a definite need for more therapy horses in our community. Currently, we have several groups within the Boise and surrounding areas who take their horses to various places, such as; Schools, Assisted Living, Veterans home, etc. However, these organizations can't keep up with the demand. So how does one start in the therapy horse arena?

First, you need a horse that 'truly' loves the attention, not just from the owner, but who really enjoys children and adults. It's obvious, the horse needs to be calm and good-natured but there are also certain training requirements that play into being a therapy worthy horse.

REQUIREMENTS FOR HANDLER:

- Control over horse at all times
- Be able to know when your horse is anxious or tired
- Health records of horse (up-to-date vaccinations), etc.
- Document of any visits prior to testing
- Horse to be groomed and cleaned for any visits
- If visiting medical facility (negative TB test)

REQUIREMENTS FOR THERAPY HORSE:

- Must stand calmly when approached by adults or a group of children
- Must not react to loud noises or unexpected sounds
- Must be potty trained or trained to wear potty bag
- Must not react to medical or housekeeping machinery
- Must have no objection to objects blowing in the wind, or flapping on either side or back
- Must be able to move easily within tight spaces or crowds of people
- Must be completely trained not to nip or bite (Biting or Kicking disqualifies for therapy work)
- Must never exhibit any aggressive behavior
- Must not object to ears, face, head, tail or back being petted
- Must be able to hug the horse with no reaction
- Can be approached from all sides back and front
- Must be able to move calmly or stand calmly around canes, walkers, wheelchairs, etc.
- Must be able to stand calmly in an elevator and/or be able to go up stair steps
- Remains calm around other animals (horses, dogs, etc.)
- Must show no reaction to approaching bikes, scooters, vehicles, etc.
- Must be trained to not go after food on trays during a visit.
- Must be trained to lead on both left and right side
- Must be able to be led by other people with no reaction
- Must not refuse a reasonable command from handler
- Must not object to wearing mini boots or hoof wraps for tile or slippery flooring

We have two people within our club who can test your horse, once they have been trained on the above requirements. The best type of training is to get your horse out in the public to see how they react and once tested, from there you can do the following: Pet Partners will test and register your horse through their organization, on visits with your horse through them, they will provide insurance for you and your horse. Please note, with Pet Partners you will have to prove your horse is potty trained, as they will not allow potty bags on your horse. They will also not allow you to have any type of costume on your horses, but they will provide a vest.

American Miniature Therapy Horse Organization will also test your horse, they will allow your horse on visits with a potty bag but they do not offer insurance on you and your horse. You will be provided with a patch, recognizing you as a AMTHA member but you need to provide your own vest or you are allowed to have costumes on your horse.

Final option, you can create your own organization, whether it's an LLC or non-profit but you will want to have your own insurance and some facilities will request documentation concerning, insurance, prior history of visits, vaccination updates, etc.





The rewards are great; you will see it in the smiles and joy when you take your horse to comfort others.
